Membership Requirements

The Bylaws of the Gasification and Syngas Technologies Council establish a General Membership category. General Members have voting rights, are eligible to hold offices, have full access to the databases, and receive priority notification about potential business and annual conference opportunities.

Membership is open to any firm, partnership, or corporation which supports the purposes of the Council, and which has a commercial interest in syngas technologies.

Syngas Technologies” shall mean technologies that produce, convert, clean or otherwise utilize syngas made by the partial oxidation of coal, petroleum coke, heavy oils, biomass, wastes, other carbon-containing solid or liquid materials, natural gas, and gaseous hydrocarbons.

The Council’s Bylaws provide that,” any eligible firm, partnership, academic institution, or corporation that meets the requirements for membership may become a member upon payment of dues. Approval of the Board shall not be withheld as to any firm, partnership, academic institution, or corporation which satisfies the qualifications for membership set forth in the bylaw.” By signing this form, the Authorized Company representative attests that the applicant meets the requirements of the Global Syngas Technologies Council.
